

Worker Safety Technology Options

Imagery/computer vision software

Analyzes customer video from existing fixed cameras in their facility and focuses on a broad view of exposures.

Risk Applications



- Ergonomics (manual material handling, awkward postures)
- Powered Equipment Operation (traffic patterns, blades up, line of sight, speeding, seat belt, load fall hazard, quick turn, collisions/near miss)
- Slip/Trip/Fall (housekeeping, jumping/climbing, obstructed vision, unprotected leading edges, floor maintenance, ladders/lifts, spills)
- Caught In (machine guarding/worker exclusion, pin hazards, pinch points)

Case Study – Shipping facility

- Computer vision detected 2,182 jumping and climbing events over a two-month period

- Heat mapping showed that 80% of incidents happened in the same location

- Recommended coaching and lift gate install reduced slip/trip/fall hazards by 99%

Wearables

Continuously monitor and capture an individual's motions, postures, work environment, etc. using devices worn by the employee throughout the workday.



Risk Applications

- Ergonomics Monitoring/Movements
- Forklift/Vehicle Driving
- Forceful Motion, Slip/Fall
- Temperature/Environmental Monitoring

Case Study – Window and door assembly plant

- Bending injuries with ongoing risk were identified
- Intervention with coaching, training and wearables haptic feedback
- 52% reduction in waist bends of over 60°
