*Workers' Comp and Spectrum® Policy Download Audit Transactions* gives you the option to receive policy download audit transactions into your AMS.

### How It Works

- › Register for this optional feature in the EBC
- › Receive final and revised audit transaction data including:
  - » Audit method type
  - » Premium change
  - » Updated payroll amounts applied to the expiring policy term

### Are You Eligible?

It's available to any producer code currently registered for and receiving Workers' Comp and Spectrum Policy Download.

## AUDIT STATUS MESSAGES

This feature delivers notifications to your AMS when a customer is at risk of having their audit estimated due to: No response, failing to complete it, or reopening it.

These notifications provide transparency into your customer's audit status so you can intervene when appropriate to help them avoid the negative outcome of an estimation.

### Eligibility

Since The Hartford just developed this new capability, it's not yet supported by all AMS providers. AMS providers who support it now include: Vertafore Sagitta, AMS360, QQ Solutions, Applied EPIC 2019 or higher, Nexsure, HawkSoft and IVANS. We're working with other AMS partners to support audit status messages in the future.



Check to see if you've opted in to Audit Transactions and Audit Status Messages in your **Automation Dashboard**. And if not, your **EBC System Administrator** can turn it on for you.
